REENTRY SERVICES ARE PROVIDED BOTH PRE AND POST-RELEASE AND INCLUDE: CASE MANAGEMENT, WORKFORCE DEVELOPMENT, FINANCIAL LITERACY, FAMILY REUNIFICATION, HOUSING, AND ASSISTANCE SECURING BASIC NEEDS.
